5. In pursuant of Gold Import and Sales/ Distribution Working Guideline, 2068, clause 24 issued by NRB, customers will submit sales details to bank within the 7 days of month. In case of failure of submission of sales details within the 7 days, bank will not include the sales details of company in submission to Nepal Rastra Bank (NRB).
